### 2. Definition of the data processed

name, address, date and place of birth, gender, mother's name, telephone number, date of arrival/departure, identity card or passport number and copies of these documents, age of guests, nationality, visa or residence permit number for third (non-EU) country nationals, date and place of entry.

### 3. Purpose of data processing

- all data, except telephone number and age of guests, necessary for NTAK data management according to § 9/H of the Tourism Act
- name, address required for billing
- the age required to determine the liability to pay tourist tax
- the purpose of the telephone number is to be contactable during the stay
- the identity card/passport number is required for asset protection purposes
- data on nationality for statistical, marketing and sales promotion purposes

### 4. Legal basis for processing

- all data, except telephone number and age, to comply with the legal obligation pursuant to Article 9/H of the Tourism Act - Article 6(1)(c) GDPR
- in the case of name and address, fulfilment of the legal obligation under Article 169(1) of Act C of 2000 on Accounting - Article 6(1)(c) of the GDPR
- name and, in the case of the age of the recipients, § 30-31 of Act C of 1990 on Local Taxes - fulfilment of a legal obligation - Article 6(1)(c) GDPR
- the telephone number, identity card/passport number and, in the case of nationality, the consent of the data subject - Article 6(1)(a) GDPR

### 5. Legal consequences of non-disclosure

The data subject cannot use the services of the data controller, so the processing does not take place.

## **6. Legal basis for the transfer and its legal basis**

D-EDGE SAS (66 rue des archives 75003 PARIS, France) for the purpose of operating the online booking and reservation system. Legal basis for the performance of the contract.

Hungarian Tourism Agency according to § 9/H of the Tourism Act. The legal basis is the fulfilment of a legal obligation.

## **7. Duration of processing of personal data**

- billing name, address - 8 years
- name and age of beneficiaries, identity card/passport number and nationality - 5 years after the last day of the reference year
- Data transmitted to the Hungarian Tourism Agency - Last day of the first year following the year of disclosure

## **8. Information on the general rights of the data subject**

The data subject has the right to.

- to be informed by the controller whether or not his or her personal data are being processed and, if such processing is taking place, to have the right to access the personal data.
- at the controller's request, without undue delay, to correct inaccurate personal data relating to him or her.
- the controller to erase personal data relating to him or her without undue delay at his or her request and the controller to erase personal data relating to him or her without undue delay where other conditions are met
- at the controller's request, the controller restricts processing if.
  - the data subject contests the accuracy of the personal data (the restriction lasts until the controller verifies the accuracy of the personal data),
  - the data processing is unlawful and the data subject opposes the erasure of the data and requests instead the restriction of their use;
  - the controller no longer needs the personal data but the data subject requests them for the establishment, exercise or defence of legal claims.
  - the data subject has objected to the processing; in this case, the restriction applies for the period until it is established whether the legitimate grounds of the controller override those of the data subject.
- receive personal data relating to him or her which he or she has provided to the controller in a structured and commonly used format and transfer these data to another controller without hindrance from the controller to whom he or she has

provided the personal data, if the processing is based on voluntary consent or on a contract and is automated.

- where personal data are processed for direct marketing purposes, the data subject shall have the right to object at any time to the processing of personal data concerning him or her for such purposes , including profiling, insofar as it relates to direct marketing.
- not be subject to a decision based solely on automated processing, including profiling, which would have legal effects concerning him or her or similarly significantly affect him or her.

## **9. Information on profiling, automated decision-making**

No profiling or automated decision-making takes place.

## **10. Data storage, data security**

The controller declares that, taking into account the state of the art, it ensures the security of processing by technical, organisational and organisational measures that provide a level of protection appropriate to the risks associated with the processing.

## **11. Right to apply to the Authority**

The data subject may take the controller to court if his or her rights are infringed. The court has jurisdiction to hear the case. At the data subject's option, the action may be brought before the courts for the place where the data subject resides or is domiciled. The court shall decide the case by default.
